2020 STUDENT (U/18 years) ATTENDANCE REGULATIONS FOR THE COMMERCIAL CLUB

The following applies in relation to students attending Events within the Club (2017)

It is required that the member or adult reserving and/or organising the event forward the following information to all the schools attending any public or privately run event.

- 1) Students must arrive in the company of an adult or teacher and be escorted to the event room.
- 2) Students are not permitted to use the facilities of the Club (eg:- café) without the company of an adult or teacher.
- 3) If students leave the venue they will not be permitted to re-enter without an adult or teacher.
- 4) Students found in restricted areas (e.g.: gaming/bar areas) unattended will be excluded from the conference and club venue.
- 5) Although students may be the legal age of 18 years, in accordance with the Department of Education regulations and Commercial Club By-Laws, students attending conferences/events are not permitted to purchase alcohol or gamble in their school uniform during school hours.
- Persons under the age of 18 years found consuming alcohol will be asked to leave the premises.

 Persons found purchasing drinks for under 18 years will also be asked to leave the premises.
